Thank you for providing the draft Request for Proposal and its proposed distribution list.

Regarding the distribution list, the ABDA would like to make note of the following two conflicts:

1. The Brattle Group, which provided expert evidence on behalf of ABCRC/ABCC in the 2019-2020 HCR.
2. ScottMadden Management Consultants, which is on retainer with the ABDA.

Regarding feedback on the RFP, I have attached a copy of the draft RFP package with one proposed revision on page 6 (of the PDF). The ABDA has struck out language referring to a recommendation for subset Return Margins on operating costs and on deposits. This language appears to be leftover from the 2019 RFP, and its removal is in keeping with the rest of the RFP and with the Return Margin Methodology Policy.
